District Engineering Representation, Term, Nomination, and Election

9.2.0 For purposes of Council representation, the province shall be divided into the following districts:

- (1) *Fredericton District: The Counties of York, Sunbury, and Carleton, and that part of Queens County north of the St. John River and the Canaan River and Washademoak Lake;*
- (2) *Moncton District: the Counties of Kent, Albert and Westmorland, and the Parish of Havelock in Kings County;*
- (3) *Northeastern District: the Counties of Restigouche, Gloucester, and Northumberland;*
- (4) *Northwestern District: the Counties of Victoria and Madawaska; and*
- (5) *Saint John District: the Counties of Saint John, Charlotte, and Kings (except the Parish of Havelock), and that part of Queens County south of the St. John River, the Canaan River, and Washademoak Lake.*

9.2.1 In each district defined in 9.2.0, one Engineering Member or Engineer-In-Training, resident in the relevant district, shall be elected to Council to represent the engineering profession.

9.3.0 One Geoscience Member or Geoscientist-in-Training shall be elected to Council to represent the geoscience profession.

9.3.1 The Geoscience Representative is elected by the Geoscientists-in-Training eligible to attend and vote at an Annual or Special Meeting.
